Assignment length, timeframe and day rate

The number of fee days shall not exceed 14 working days at a rate of US\$300/day. We operate a system of honest reporting whereby a consultant self-reports his/her time usage. Thus, total fees payable shall not exceed US\$4200. The payment will be made upon approval of the deliverables:

- Phase 2: 40% Upon Submission of Second Draft Report and Thematic Partners Atlas.
- Phase 3: 40% Upon Submission of Final report and Thematic Partners Atlas.

Days will only be billed if the outputs are delivered to the agreed standard, and days per output are agreed in advance. The hours may be split and can be used outside of 9am to 5pm. Note it is the responsibility of the consultant to raise any issues with completing deliverables within the timeframe with the focal person at the earliest opportunity.

Note: The consultancy fees shall be paid less 30% withholding tax, if no tax clearance is availed.

The Consultant is to undertake data analysis and report writing using data collected from various education development partners, and consultation process on the implementation of the Zimbabwe Early Learning Policy. Thereafter, make recommendations to both the Ministry of Primary and Secondary Education and Education Development Partners, and Potential Funders. Education Development Zimbabwe (EDZ) is therefore seeking an STTA to:

- Develop thematic summaries to guide the provincial consultation using data from online data collection tools emailed to stakeholders involved in early learning.
- Analyse consolidated provincial consultation sessions feedback.
- Draft preliminary findings based on Provincial consultations and National level discussions.
- Prepare the final report based on stakeholder reviews and comments.
- PowerPoint presentation summarising findings.
- Developing interactive ECD thematic partners atlas.
- Participate in validation workshop as required.
- Provide a final report on findings after incorporating feedback from stakeholders.
- Submit all sets of data used for the report.

Objectives of the consultancy

- In-depth and objective analysis of consultation process data to develop a report that will enhance operationalisation of Zimbabwe Early Learning Policy.
- Consolidated findings and recommendations based on the collected data, including an interactive and editable partner atlas map.
- Effective engagement with Ministry of Primary and Secondary Education to enhance early learning programming in Zimbabwe.
