Job Title: Senior Commercial Finance Analyst

### **Job Purpose:**

To provide commercial support to the UK portfolio. This will cover provision of insightful financial performance information, creating an environment within the business of financial understanding and sustainability. This role is a key support to the UK Commercial Finance Lead to help drive the business to meet the financial model.

# **Job Objectives:**

- 1. Provision of commercial support to UK-based budget holders and managers in the delivery of their in-year and longer-term financial objectives. Assisting with internal and external financial reporting as required
- 2. Use business data provided by the finance function and analysts pertaining to all commercial activities to provide challenge and support to the UK management teams to drive financial returns and ongoing efficiencies into the business. Specifically, perform a challenge and support role to budget holders
- 3. Support in the provision of visibility on the financial performance of contracts in the short, medium and long term. Ensure that where appropriate activities meet or improve on budget, cost, volume and efficiency targets and Key Performance Indicators in line with business objectives









- 4. Provide advice and guidance to budget holders on best practice financial commercial standards to maximise contract margins across the portfolio, balancing delivery imperatives
- 5. Consult and review contract budgeting/forecasting projections with budget holders, providing point of contact for challenge, clarification, and analysis and advice on areas of risk/opportunity within contract financial performance. Support the delivery of financial goals and ensure they are within required business and contract priorities
- 6. Identify, report and monitor financial risks across the UK business, identifying mitigating actions to bring back to budget targets
- 7. Support the approach to increase stakeholder knowledge and understanding of the financial consequences of decisions throughout the business, improving commercial awareness through the delivery of briefings and training
- 8. Provide support to Commercial Finance Analysts where appropriate
- 9. Produce ad hoc financial reports as requested by the Finance Management Team and budget holders
- 10. Carry out other such activities to support the Commercial Finance Team

# Scope:

The postholder will work closely with the UK business leads, supporting to advise and challenge the financial and commercial performance of the portfolio. The postholder will need to be flexible in approach to working patterns and environments, with a requirement to travel to support Education Development Trust's operations
