# Job Purpose:

To act as the leading executive of CfBT Brunei Services (B) Sdn Bhd, with reporting accountability to the Board of Directors of that Company as well as Education Development Trust (edt). Ensure all businesses in Brunei meet financial, operational, and educational impact targets, and serve as the senior point of contact for all clients in Brunei, particularly the Ministry of Education. Lead the Senior Management Group to optimise high performance, ensure full and effective delivery of the English Language Teaching Project (ELTP) and contribute to long-term strategic success by raising the profile of CfBT in the South East Asia region.

# Job Objectives:

- 1 Provide overall leadership and management of all CfBT's activities and business development operations in Brunei, ensuring that corporate targets are achieved and that a high-performing, integrated team is built in country.
- 2 Manage operations within the company to ensure that projects deliver educational impact and financial returns and that all support functions contribute to the effective and efficient delivery of services.
- 3 Oversee and take accountability for the educational delivery of ELTP, ensuring the quality of educational impact Is delivered. Ensure delivery plans are informed by



- evidence of education impact from edt and the wider education sector, and apply learning as appropriate.
- 4 Lead and develop strategic relationships with the Ministry of Education, the Board of Trustees and other key stakeholders, representing CfBT and edt effectively and credibly at external facing meetings.
- 5 In collaboration with clients, negotiate and establish clear annual targets for educational impact, including but not necessarily limited to any targets specified in contracts of service.
- 6 Lead a smooth transition and handover of the secondary teaching contract to the Ministry of Education. Ensure all resources and learnings are transferred to the Ministry and support the performance and motivation of secondary teachers as they transition from CfBT Brunei.
- 7 Be accountable for and embed a clear commitment to safeguarding and health and safety risk management in all departments of the Brunei businesses. Adhere to edt's safeguarding and child protection policies and reporting procedures, ensuring the safety, health and well-being of children and students is maintained at all times.
- 8 Report to the Company Board and to the edt Executive Team on operational, educational and financial impacts and ensure compliance with Brunei regulations and UK reporting requirements.
- 9 Set and meet profit and loss targets in conjunction with CfBT's Board of Trustees and edt and oversee commercial and financial reporting, minimising fiduciary risk.
- 10 Grow and develop company businesses within Brunei and the region as set out in an agreed strategy.
- 11 Manage corporate governance such that systems and processes are robust and fit for purpose. Ensure financial controls and cyber security are in place and that operational reporting is meaningful and accurate.
- 12 Play an active role in the wider edt Senior Operational Management team, contributing to the Chief Operating Officer's report, utilising the business management systems and engaging in the strategic planning process.
